December 14, 2016 Olin 304

#### I. Minutes

#### **II. NEW BUSINESS**

#### 1. Consent Agenda

#### a. FYI 103 (Colvert)

Consent agenda item FYI 103 (Colvert) was reviewed online by the members of the committee and approved. No further discussion was needed at the meeting. **APPROVED**.

#### 2. Course Approvals

#### a. LC – COMM 499 and SOC 100 (Varallo and Shea)

While the committee was willing to discuss the approval of this course to accommodate an urgent situation, concerns were raised about whether or not this course would be a purposeful interdisciplinary experience and whether the amount of preparatory work was worth the effort for just one student and a one-off case. The committee inquired after alternatives that might be available to the student, other than the construction of an "emergency LC," to solve the student's academic dilemma. After extensive discussion of the situation, Mike Egan suggested the committee table this proposal until Jeff Ratliff-Crain could address the committee's concerns with the professors and explore other options available to the student for which this course was proposed.

Motion – Lisa Seidlitz moved to table **LC – COMM 499 and SOC 100 (Varallo and Shea)**; Amanda Wilmsmeyer seconded.

MOTION TO TABLE LC - COMM 499 and SOC 100 (Varallo and Shea) PASSED.

#### **III. Gen Ed Curriculum Under Semesters**
