

Declarations of Intention and Naturalizations in New Sweden, ME 1873–1900

In my presentation of the early Swedes, who filed *Declarations of Intention* in Rockford, IL from 1859 to 1870, I referred to the importance that this document, as well as the *Certificate of Naturalization*, have in genealogical research (*SAG*, Vol. I, No. 1, pps. 7-14). These official papers most often constitute proof of birth, but may also provide additional information concerning the place of birth, port of arrival in the U.S., date of arrival and perhaps even the name of the vessel on which the immigrant arrived. Not all of this information is available on every document. Practice differed from place to place and the amount of information demanded of each petitioner often depended upon the clerk of court, who was empowered to elicit such information. Whatever information we can extract from these two forms, however, i.e. the *Declarations* and the *Naturalizations*, the material gathered constitutes another piece in the puzzle in the completion of the family story.

Valuable as these records are, they are for the most part difficult to locate and to use, because before 1906, naturalization records are scattered among hundreds of courts, the files reposing in obscure and difficult-to-find storage areas. Since they constitute an important source, yet difficult to work, it has seemed important to this writer to ferret out material in long forgotten storage areas and to make this material available to the searcher in the hunt for his Swedish origins. A start was made with a survey of the early *Declarations of Intention* for Rockford, a study which will be resumed in the pages of *SAG* at some future time. At this stage, however, we are going to turn our attention to another area of heavy Swedish settlement, New Sweden, Maine.

Most Americans of Swedish descent are aware of the unique position the Swedish colony in New Sweden holds in American Swedish historical annals. Most Swedish settlements came about gradually by means of a slow build-up, such as Chicago, Minneapolis, Rock Island, IL, Jamestown, NY and Worcester,

MA. Two cases come to mind, where the idea of a single person triggered the instant formation of a Swedish settlement. The best known of these is, of course, the Bishop Hill colony in Illinois in 1846, founded by the religious zealot, Erik Jansson. The other was the Maine experiment which took place in what was to be known as New Sweden in 1870.

Much has been written on the formation of the colony in New Sweden, Maine and the reader is referred to the literature on the subject. Other recent studies have concentrated on the formation of the nearby settlements of Woodland, Westmanland and Stockholm, ME. A short resumé of what brought about the formation of the New Sweden settlement is, however, necessary in order to give an adequate background to the main subject of this study — the listing of the New Sweden settlers who declared their intentions or procured their U.S. naturalization papers.

In the middle of the Civil War President Abraham Lincoln dispatched a bright young Bowdoin College graduate, William Widgery Thomas, Jr., to Göteborg, Sweden as the U.S. Consul. There Thomas became enamored by Sweden as a country, its people, its customs and its language. He soon plunged into learning Swedish. He eventually married a young Swedish lady.

As the chief U.S. officer at the American Consulate in Göteborg, he witnessed the rising exodus of young Swedish men and women, passing through the seaport, en route to America, mostly to the Middle West. Being a proud Yankee from Maine, he pondered why a part of this tremendous reservoir of human ability and energy should not be deflected to the northern reaches of Maine. When he returned to Maine in 1866 to open a law practice in Portland, he kept mulling over his idea of attracting Swedish immigrants to his own state. He planted his idea in the right places, he twisted arms, struck political deals, finally getting a law passed in the Maine State legislature, called the "Thomas Plan", which offered each immigrant 100 acres of free land, a cabin, and a small clearing. He got himself appointed as one of three state commissioners for settlement of the public lands of Maine, taking for himself the task of commissioner for immigration.

He wheedled an appointment from the governor of Maine to proceed to Sweden to find 25 Swedish families who would be willing to settle in the northern regions of Aroostook County. In a little more than a month after his arrival in Sweden in 1870, he had spread his appeal all over Sweden and by Midsummer he was able to select a small group of colonists, willing to make the journey — twenty-two men, eleven women and eighteen children, for a total of 51 individuals, led by the energetic Thomas. A month later, or on July 23, the group arrived in what was to become New Sweden. Thirty-two additional colonists arrived before the cold weather and by the end of 1870 the settlement housed a total of 114 souls. Not a single case of illness had developed among the settlers, speaking well for the general health of the newcomers, as well as the salubrious climate of northern Maine. By the end of the year the New Sweden colony was a fact and Thomas' idea had been put into practice.

A year later the colony had swelled to almost 500 persons, and as the years passed still others came, although these numbers were balanced in part by the attrition caused by the exodus of young men and women, who, not finding the job opportunities in their small community, sought their livelihood in larger and older communities like Caribou, Presque Isle, Bangor and as far away as Portland and farther south in Worcester, Boston and Providence.

American citizenship was an important goal for most of these early colonists. As they settled into their new homes, cleared the forest and planted potatoes and grain, this ambition became stronger as they felt themselves rooted in the American community. This was particularly true as their children were born in the new land. The nearest court for the purposes of acquiring U.S. citizenship was the Supreme Judiciary (today known as the Superior) Court of Aroostook County at the county seat in Houlton. Since Houlton was situated 66 miles south of New Sweden, it was a long and arduous journey for the colonists to visit their county seat. Since so many of the petitions to be found in the registers are numbered consecutively for groups of Swedes, it is possible that they visited Houlton in a group or that the clerk of court visited New Sweden in order to facilitate the process. Eventually the population of the northern part of the county grew to such an extent that it was necessary to establish a district court in Caribou, ten miles south of New Sweden, where many of the later Declarations of Intention and Final Naturalization Certificates were executed. Today, however, all of the naturalization records for Aroostook County are to be found in the offices of the Clerk of Court in the Superior Court in Houlton. Here they may be examined and studied.1

For the purpose of this study, which is limited to the early years of the New Sweden colony, up to and including 1900, a total of nine volumes were examined, volumes 2-10. Volume 1 could not be located but since it antedates Vol. 2 (1839–1852) it is highly unlikely that it would contain any Swedish names. As a matter of fact the Swedes do not appear until well into volume 6. The earliest entry is Oct. 14, 1873, when a total of 37 Swedes declared their intention and were recorded by the clerk of court. The first Scandinavian, however, was Ole Hansen of Sherman, ME, who had arrived from Drammen, Norway in 1857. He received his final naturalization in Houlton Feb. 23, 1869, the first entry for a Scandinavian settler.

The names on the following list are recorded as found in the original records. Only where the signature of the petitioner appears to vary from the clerk's entry, is the petitioner's version used. For scholars interested in researching these official documents it should be pointed out that the original record on file in Houlton contains in most cases the original signature of the petitioner.

Then follows the place of abode of the petitioner, when known, his petition number, with the volume number given first, followed by the page number in that volume. Since all were born in Sweden, this column has been skipped in the list reproduced. Then follows the age of the petitioner, his year of arrival in the U.S., when known, and the date of filing the declaration of intention or the date of

the final naturalization certificate. In order to simplify the listing I have calibrated the year of birth by subtracting his age at the time he arrived in the U.S., or the time when he received his final papers.

In checking this extrapolated birth year against other sources giving the petitioner's birth year, such as tombstone inscriptions and parish registers, it has been found that these dates coincide with the calibrated birth year very well.

In order to put more "flesh on the bones", the parish registers of the Gustaf Adolf Evangelical Lutheran Church of New Sweden have been used extensively. It is estimated that somewhat more than half of the New Sweden colonists affiliated with the Lutheran Church, the closest church organization to their native church in Sweden. A great many newcomers were Baptists, however, and shortly after the colonizing the Evangelical Covenant Church was established in New Sweden. It has not been possible to consult the records of either the Baptist Church, nor the Covenant Church.

A few town records of Woodland were consulted³ as were a number of grave markers in three of the smaller cemeteries in New Sweden — Jemtland, Rista Road and Westmanland, as well as the Woodland Cemetery.⁴

There are doubtless many other ancillary sources which could have been consulted, such as newspapers, U.S. Census records, diaries, letters, last wills and testaments, land records, and a host of other source materials, but there has not been the time nor the opportunity to study each petitioner's life story in depth. The main purpose of the list which follows is to document every Swede, who, between the years of 1873 and 1900, sought to establish U.S. citizenship. As such it can be used as a checklist for any researcher, who can demonstrate his descent from one of W. W. Thomas' "children in the woods".

William Uggla — A Civil War Swede

One of the rewards of genealogical research is to learn more about a person than just the bare facts. Dates and places of birth, death, marriage, etc., serve only to identify a life. They do not tell what a person did with his or her life. This story deals with my efforts to learn more about the life of a distant relative, who came to America before the Civil War and who later became a victim of that war.

Conrad Vilhelm Mattias Uggla was born in the city of Karlstad (Värm.), Sweden on August 26, 1821, the son of Carl Vilhelm Uggla, a captain in the Värmland Field Rifles Regiment (*Fältjägareregemente*), and Sara Johanna Frykman. He entered the University of Uppsala in 1840 and seems shortly thereafter to have left for America, according to Elgenstierna.

Elgenstierna goes on to mention that in the United States Uggla served with the 159th North American Regiment, that he returned to Sweden, where he taught foreign languages in Stockholm in 1857 and that he subsequently returned to the U.S., where he enlisted in the Union forces in 1862 and later was killed in the Battle of Port Hudson May 27, 1863.

Armed with this information I thought that the primary move was to check the military records of the U.S. Army during the Civil War period. Upon investigation I found that it was possible to research military service records at the National Archives in Washington, DC and a request went off to the Archives, asking for a complete file on Conrad Vilhelm Mattias Uggla.²

The National Archives proved to be very cooperative and back came a file, which provided a great deal of fascinating information concerning Uggla, who upon enlisting in the U.S. Army had shortened his name to William Uggla. The first piece of information told that William Uggla, 38 years old, had on Sept. 16, 1862 married a Swedish lass from Halmstad, Sweden, named Anna Sophia Djurburg (Djurberg) at the City Hall in Brooklyn, NY. She was 26 years old at the time. On the same day William Uggla enrolled as an original member of Company H, 159th Regiment of New York Volunteers for military service in the War, for a term of three years or the duration of the war. The enrollment papers state that he was 5 feet, 7 inches tall, had light complexion, blue eyes, light hair and was by occupation a sailor. Company H was mustered into service on Nov. 1, 1862, at which time William Uggla was listed as a corporal.³

From these records we learn that Elgenstierna was in error when he states that Uggla joined the 159th Regiment in the 1840's, or on his first visit to the U.S. We can also only speculate as to William Uggla's return to America in 1862. Was

this due to his interest in joining the Civil War struggle, or his interest in marriage, or both of these motives?

The next item in the file is a letter dated June 21, 1863, written by Capt. W. O. Pettit of Company H, addressed to Mrs. Sophia Uggla. It reads as follows:

Dear Madam:

It becomes my very painful duty to inform you of the death of your beloved husband, Mr. William Uggla of Co. H, 159th Regt. N.Y.S.V. After having passed successfully and gallantly through the Battle of Irish Bend, we were ordered on the 27th Ult. to charge a rifle pit in possession of the enemy, and with four others of my company killed, he fell while pressing forward to the charge.

Receive, Dear Madam, my heartfelt sympathy, and also of the entire company.

Respectfully, your most obedient servant

W. O. Pettit, Captain³

In this battle in Louisiana, the Union forces pushed up the Mississippi River after capturing New Orleans, while other Union forces were pressing from the North. Following the capture of Vicksburg by Union units from the North and the capture of Port Hudson from the South, the Confederacy was cut into two parts and was doomed to defeat.

The next item in the file was correspondence from Anna Sophia Uggla, who after her husband's death, had returned to Stockholm. It is dated June 30, 1865 and is in the form of an application to the United States Government for a pension as being a widow of a soldier killed in battle. It was duly notarized and transmitted to the United States Consul in Stockholm.³

Following this is a letter from the Swedish Consul in New York to the Commissioner of Pensions in Washington, DC, endorsing the request.³ A later letter from the Swedish Consul on New York indicates that Mrs. Uggla was suffering great poverty.³

Finally on Jan. 19, 1866, almost three years after Uggla's death, the United States War Department approved a pension for Anna Sophia Uggla in the amount of \$8.00 per month, retroactive to May 27, 1863, the date of William Uggla's death.³

The next thing to do was to learn more about the early life of William Uggla, or Conrad Vilhelm Mattias Uggla, as he was known in Sweden. Here I found that the sources of the Swedish House of Nobles (*Riddarhuset*) came in good stead. This institution is the official depository for all the records dealing with the Swedish nobility. Its director and chief genealogist is Dr. Pontus Möller, who provided me with as much material as it was possible to gather.

Dr. Möller referred me to Elgenstierna, which contains biographical material concerning Uggla's father, Captain Carl Vilhelm Uggla, who had fought in Sweden's War with Russia 1808–1809.⁴ He also contacted the provincial archives in Göteborg (*Göteborgs landsarkiv*) as well as the Stockholm City Archives. The records of the parish church in Karlstad, young Uggla's birthplace, show that he had returned in 1857 to Karlstad from California and that he was

"not free to marry — abroad". What this cryptic remark may mean is difficult to say. Was Uggla married in California? Had he left his wife behind?

That he resided in California is proved by the entry in the U.S. Census for California of 1850, which shows that on Dec. 4 of that year a William Uggla, 29 years old, a native of Sweden, by occupation a miner, was living on Dry Creek, Eldorado County together with another Swede named Charles Fleming. He was not married at this time, inasmuch as his wife would have been included in the census.

Though we have learned a great deal concerning Conrad Vilhelm Mattias Uggla, we are still left with many unanswered questions. When did he first leave Sweden for California? Olsson's two volume work on Swedish passenger arrivals in the U.S. 1820–1850 do not mention him. The passenger manifests for the city of San Francisco burned in a disastrous fire in the 1940's and can give us no help.

Uggla may have arrived in the U.S. as a sailor aboard a Swedish vessel or some other vessel, which may account for his not being listed on any passenger manifest. This theory is also strengthened by the fact that he was listed as a sailor at the time of his enlistment.

The thousands of crew lists on deposit in the National Archives in Washington may yield the information, but since these lists have not been indexed, it would be a herculean task to sift through this enormous collection.

Other questions remain. Who was the girl he seems to have married in California? What happened to her? As is true with most genealogical research, new information yields new problems. Perhaps some day we shall find the answers. In the meantime, we are beginning to get a clearer picture of Conrad Vilhelm Mattias Uggla, alias William Uggla, a university-trained son of a Swedish army officer, who on two occasions answered the call of adventure from the New World and who finally gave his life for a cause to which he had been attracted. It is discoveries such as these which make genealogical research so rewarding.

Swedish Burial Records in Chicago Cemeteries

The city of Chicago, at one time the second largest Swedish city next to Stockholm, has since the 1850's attracted tens of thousands of Swedish immigrants. While many of these newcomers remained in Chicago just long enough to get their bearings, before striking out for greener pastures farther West, vast numbers of them settled in Chicago, carved out their careers there, married and raised families there, and ultimately died there. Their final remains, therefore, came to rest in one of the more than sixty cemeteries to be found in the present-day Chicago Metropolitan area.

For the genealogist a cemetery can be an important place in which to locate pertinent material for the family history. To name and locate all of the Chicago cemeteries is beyond the scope of this short study. Three cemeteries exist in Chicago, however, which across the years have become the final resting place for thousands and thousands of Swedish immigrants. These cemeteries, all non-sectarian, are all more than a century old, and have served the Swedish population of Chicago for almost 125 years. These are — Graceland and Rosehill on the North Side and Oak Woods on the South Side. All are private grave yards, which have maintained excellent burial records for the time of their existence, thus enabling the researcher to find clues in identifying kinfolk who arrived in Chicago as far back as before 1850. All of these cemeteries have records which antedate the Chicago Fire in 1871, which makes these cemetery records even more valuable, considering the destruction of most of Chicago's vital statistics in that conflagration.

Rosehill Cemetery

Rosehill is the largest non-sectarian cemetery in the Chicago area, occupying some 350 acres on Chicago's North Side, bounded on the east by Ravenswood Ave., on the west by Western Ave., on the north by Peterson Ave., and on the south by Bryn Mawr and Bowmanville Aves. It was chartered by the Illinois State Legislature on Feb. 11, 1859 and the first burial took place there July 11 of that year, shortly before the dedication of the cemetery July 28, 1859. Since that time close to 200,000 persons have been interred here. Every grave is registered and there is a card for every person buried in this cemetery. These cards are on file in the offices of the cemetery association and carry such pertinent information as name of the person, age at time of death, time of death, date of burial and location of the burial plot. There is also a chronological account of all burials, where, if one knows the name of the person, one may also procure such additional details as the cause of death, residence at the time of death, and in some

instances the names of the attending physician and mortician.1

The management does not charge for an inquiry or two, but discourages multiple queries, because of an overworked staff, and may in such instances charge for each inquiry. For those submitting queries it is recommended that one or at the most two questions be submitted, accompanied by a stamped self-addressed envelope. Send all inquiries to Rosehill Cemetery, 5800 Ravenswood Ave., Chicago, IL 60660.

A sampling of the information available proved that here was a veritable gold mine of information. I had for years been looking for information of what happened to a Swedish pharmacist by the name of Pehr Olof Rosin, who originally emigrated to New York in 1843 and was living as a druggist in New York in 1850.² He subsequently returned to Sweden, married and had several children. In 1880 he re-emigrated to Chicago, where he continued his career as a druggist. The last word concerning him reached Sweden in 1899. A quick check of the Rosehill Cemetery records showed that Peter O. Rosin died in Chicago April 25, 1900 and that he was buried in Rosehill. Furthermore I learned that Pehr Olof's son, Conrad, who also had emigrated to Chicago, was buried in Rosehill together with his wife, Justina. While no tombstone could be found for the elder Rosin, there were headstones for both the son and the daughter-in-law.

Graceland Cemetery

The other large cemetery on Chicago's North Side is the Graceland Cemetery, which received its charter from the Illinois State Legislature Feb. 11, 1861. Graceland is smaller than Rosehill, comprising about 119 acres. It is bounded on the west by Clark Street, on the north by Montrose Ave., on the east by Eastwood Ave., and on the south by Irving Park Road. This cemetery also maintains excellent burial records, which are available to the scholar for a fee of \$3.00 per inquiry. For this amount the searcher receives a xerox copy of the grave plot history with the names and the dates of persons buried there, their dates of death as well as age at the time of death. Send all inquiries to Graceland Cemetery Company and Crematorium, 4001 North Clark St., Chicago, IL 60613.

Here I also wished to check a record, to see what information was available. I picked at random the name of John Matthias Schönbeck, one of the oldest settlers in Chicago, who had arrived there in 1847. He had been very active in the Swedish colony, had served as a vestryman in the St. Ansgarius Episcopal Church and had been one of the founders of the Svea Society in Chicago in 1857. He had died Oct. 2, 1873, but I did not know where he was buried.³ A cursory examination of the card file indicated that indeed John M. Schonbeck was interred in Graceland Cemetery in 1873. His wife, Johanna Bergvall, who had arrived in Chicago 1849, had died March 1, 1910 and she is also buried here as is her daughter, Agnes Wimmermark, who died as recently as 1953. To show that a family plot continues to be used by the family over a period of years, I found a notation that a granddaughter, who lived and died in Philadelphia, had been interred in the Schonbeck family plot in 1960. The first burial had been in 1870

when Schonbeck's 18 year old daughter had been buried here. Thus the card file indicates a history of 90 years of Schonbeck burials in this cemetery.

Occasionally a grave stone will also give information of the birth place of the person interred. While I did not spot any Swedish stones with this type of information during the very short visit, I found the following headstone giving information concerning a Danish immigrant by the name of Niels Uhrenholdt, born in Hobro, Denmark April 23, 1828. He died in Chicago Nov. 19, 1883.

Oak Woods Cemetery

Oak Woods Cemetery on Chicago's South Side was organized by a group of Chicago leaders in 1853 and thus antedates both Rosehill and Graceland. It comprises 183 acres and boasts of a special area within the cemetery known as the Swedish Section. More than 175,000 persons have here found their final resting place. The cemetery is bounded on the north by East 67th Street, on the west by Cottage Grove Ave., and on the south by East 71st Street. The records maintained by the management are in excellent condition, dating back to the Civil War. The first Swedish burial was that of Charles William Pettison, who died July 10, 1865 and was buried in Oak Woods July 11, 1865. He was born in Sweden in 1846 and had resided in Woodlawn with his parents, Peter and Christine Carlston (sic!). The cause of death was given as typhoid fever.

The management welcomes inquiries regarding persons interred here but charges \$2.00 per inquiry plus a stamped and self-addressed envelope. For this sum the management will furnish the name of the deceased, date of death, date of interment, age at time of death, place of birth (information which neither Rosehill nor Graceland could furnish), place of death and the next of kin as well as information concerning the grave plot. Inquiries should be directed to The Oak Woods Cemetery Association, 1035 E. 67th Street, Chicago, IL 60637.

If the researcher does not know in which Chicago cemetery the object of the search is buried, it is possible to procure this information by writing to the Department of Health, Burial Permit Office, Richard J. Daley Center, Randolph and Clark Streets, Chicago, IL 60602. The charge for each search is \$3.00, for which the inquirer receives an affidavit showing the name of the deceased person, his or her date of death, the cause of death, the name of the mortician, the age at time of death and the important information concerning the cemetery where the person is buried.

The brief visit to these three Chicago cemeteries convinced me that here was a valuable source of information concerning persons who have died and have been buried in Chicago. The inventory of the remaining Chicago cemeteries would doubtless reveal additional information, but that will have to wait until another time.

Naturalized Scandinavian Seamen in Boston 1815–1840

Scandinavian seamen, serving aboard American merchantmen in the first part of the 19th Century, soon learned of the advantages of becoming American citizens. One of these advantages lay in the preferential treatment they received in the hiring policy of U.S. masters. These were required by U.S. law to employ American sailors, if such were available. It was only when the master of an American vessel could not find a U.S. citizen to fill a vacant berth, that he could hire a foreign seaman legally.

The second advantage lay in the access to the seamen's protective certificate, a very important document on the high seas and in foreign ports during the Napoleonic wars, when British masters often would board U.S. vessels at sea for the purpose of impressing seamen to man their own ships. British officials held the view that a British subject could not renounce his citizenship. Since most American sailors had been born in the American colonies before the U.S. Declaration of Independence, and thus born on British soil, Britain's view was that such persons legally were British citizens.

Seamen's protective certificates had been issued in various forms prior to 1796, but in that year American public opinion was inflamed by the British boarding of the U.S. vessel "Lydia" and impressing five American seamen. The U.S. Congress, stung by this affront to the U.S. national sovereignty, promptly passed a law May 28, 1796, which spelled out a national policy in the hopes of stemming or stopping the British harassment.

The law directed the customs collectors in various U.S. port districts to keep a register of all American seamen, who presented some proof of U.S. citizenship and, for a fee, to issue a seamen's protective certificate to the sailor in question. In order to get a certificate the seaman had to show some form of citizenship proof, such as a birth certificate, a passport, an old seamen's protective certificate issued at another port, or to take an oath, administered to him by a port official or an alderman. For foreigners, who had been naturalized American citizens, it was usually sufficient to produce the naturalization document.

British naval authorities did not always honor these certificates, and it was the end of the Napoleonic wars and the lessened need for sailors aboard British warships which gradually stopped the impressments. Actually the British did not formally drop the principle of the right to impress until 1870, but by that time the danger of impressment had all but vanished. Nevertheless, the U.S. Government continued to issue seamen's protective certificates up to the beginning of the Civil War.

The law of 1796 specified that the collector of customs in each port district was to issue the certificate and to keep the applications and proofs of citizenship on file, which at stated intervals were to be sent to the Secretary of State in Washington. In addition the customs collectors were to forward lists of registered seamen, also called abstracts, to the State Department.

Today the National Archives in Washington houses all of the abstracts from the various port authorities. Seemingly the original applications have been preserved only for the port of Philadelphia.

Known as Record Group 36 these records are a part of the collection of the Bureau of Customs in the National Archives, where they are available to the researcher and scholar alike.

So far as is known, very little research has been done with this important genealogical source, except for the work of Ira Dye, a Washington researcher, who has utilized the Philadelphia applications for seamen's protective certificates for the years 1812–1815 and has computer processed the tabulations, coming up with some very interesting statistics covering some 790 applicants for the Port of Philadelphia.¹

In order to determine to what extent Scandinavian seamen availed themselves of the opportunity to procure these protective certificates, it was decided to go through a series of abstracts for the port district of Boston and Charlestown, Massachusetts. All abstracts for the period 1815–1840 were carefully examined and all Scandinavians extracted and tabulated — 117 names in all. The following information can be gained from a study of these abstracts — the name of the seaman, his date of application for a certificate, the application number, (which is academic, since the original applications for this port district seem to have been lost), the sailor's age, his height in feet and inches, (within a quarter of an inch), his color of complexion and the city of his birth and the country of which he had been a citizen before his naturalization.

Some of the names of the cities have been badly garbled, and though these can be reconstructed fairly accurately, a few defy solution. The place names are rendered as written, but with the intended or modern spelling within parentheses. In the case of the two cities of Copenhagen and Gothenburg, the accepted English forms have been retained.

Of the four Scandinavian nationalities represented here — Danes, Finns, Norwegians and Swedes, the Danes easily outdistance the rest, by having 65 applicants, the Swedes are in second place with 37, the Norwegians have seven and the Finns two. Since Norway and Sweden were joined in a dual monarchy from 1814 to 1905, it is sometimes difficult to determine the applicant's nationality. In three instances the place name is given as being in Sweden, yet the names

are doubtless Norwegian, as for instance Arundel for Arendal, Crocker for Kragerö and Draman for Drammen. In one instance the nationality is given as Norwegian-Swedish, which automatically places that seaman in the Norwegian category, thereby raising the Norwegian score to eleven. One name is listed as Danish-Swedish and one person has no nationality given for him at all, but since his name is Lunneburgh, it almost surely places him in the Swedish category. One Swede, John Peterson, seems to have applied twice, first in 1838 and then again in 1839, and Frederick Wentt, a Dane, applied both in 1837 as well as in 1840.

The heavy preponderance of Danish applicants may have as one of its reasons that before 1866, Denmark included large sections of north-west Germany, Schleswig-Holstein, which today is included in the German Republic. This is corroborated by many of the Danish applicants who came from such German cities as Holstein, Grossenbrode, Flensburg, Glückstadt and Elmshorn.

It has been possible to further identify a number of the Swedish applicants, by consulting the naturalization records in Boston. These records have yielded such information as birth date, sometimes place of birth, as well as the date of naturalization and the court where such naturalization took place. This additional information is given in notes at the end of this article.



Commentary on Query 13

Several readers have responded to the query dealing with Julius Bernadotte. Erik Wikén suggests that Julius and Bernadotte were the buried Swede's baptismal names and that he possibly dropped his own surname and substituted his Christian name Bernadotte. This is quite possible, inasmuch as Bernadotte was not an unusual, if not frequent, boy's name in Sweden, after the election of Jean Baptiste Bernadotte, Marshal of France, as the Crown Prince-elect of Sweden at the Swedish *Riksdag* in Örebro in 1810. Based upon his age at the time of death, Julius Bernadotte must have been born in 1811, a year after the Swedish election.

The drawing reproduced below was made by H. A. Hjersman, member of the Vasa Order of America, Monitor Lodge No. 218. Col. Axel Friman of Göteborg, Sweden, visited the site of the grave stone in April, 1981 together with another member of the Vasa Order, Ed Range, who promised that his son Rick would see to it that the cracked stone would be repaired, restored and replaced on the original site.

Olsson, Peterson, Buler

My grandparents, Per Johan and Britta Maria Olsson, left Göteborg June 17, 1870 with four children for America (according to the Göteborg Police Register in the Göteborg Provincial Archives). The family had lived in Fogdhyttan in Nora Parish (Öre.), and seems also to have lived in Sandviken (Gävl.). Somewhere along the way, until they emigr., Olsson changed his name to Buler, but upon arrival in the U.S., he again changed it to Peterson. Per Johan Olsson was b. in Gåsborn Parish (Värm.) as Johan Buler and is listed in the parish register as a part time mine owner. Buler sounds German to me. How can I trace his movements in Sweden before his departure for the U.S., and also find out why he changed his name?

Comment: Buler may be German, but it might also be a Walloon name. The fact that the grandfather was engaged in mining strongly suggests this, since many who worked in the mines or iron smelters were of foreign origin. The Buler name is known both in Stockholm and in Västmanland. So far as tracing his movements in Sweden, it might be worth while to begin with his birth place in Gåsborn and then attempt to follow him from parish to parish via the parish exit lists.
