Transcription:

Extracts of the list of Journals of Passports issued at the Carlstad County Office in the month of January in the year 1814:

Year, Month and Day, when the Passport was issued	Name of holder of Passport, age, appearance and domicile, office, profession or service, and the place the traveller comes from.	Which towns the Traveller ought to pass through, the place which is his destination or place where he will be staying, and for which period of time the passport will be valid.

5	Inspector Hesselius from Deije	Within this county and to Fahlu county for 3 months

"	The judicial adviser (<i>auditör</i>) A. G. Salmenius	Within this county, Älvsborg, Skaraborg and Bohuslän for 1 year
7	The bookkeeper B. Branzell	To Älvsborg county for 1 month
