Q does not seem to line up with interpret as strongly as the committee felt it should.

HEPE not reinforced by SLOs. Is it really a part of the core curriculum?

The next step would be to begin redoing expectation and proposal forms for gen ed designations and including SLOs that courses should work towards

This term we will continue to work on the multiple/partial LC policies.
